| Statement | <p>1.0 RATIONALE</p> <p>In an ongoing effort to increase efficiencies through greater co-operation, the Thunder Bay Catholic District School Board, (Hereinafter called "TBCDSB"), Lakehead District School Board, (Hereinafter called "LDSB") and Conseil Scolaire de District Catholique des Aurores boreales, (Hereinafter called "CSDCAB") have adopted a joint policy regarding student transportation for the Thunder Bay area.</p> |
| Policy | <p>2.0 STUDENT TRANSPORTATION</p> <p>2.1 Transportation will be organized and delivered by the Student Transportation Services of Thunder Bay Consortium on behalf of its three (3) member school boards: Thunder Bay Catholic District School Board, Lakehead District School Board, and Conseil Scolaire de District Catholique des Aurores boreales.</p> <p>2.2 Pursuant to the Educational Act, R.S.O. 1990, school boards may provide transportation to their students.</p> <p>2.3 The school boards will provide transportation, without charge, to students whenever such transportation is warranted in accordance with the guidelines outlined in this policy.</p> <p>2.4 Any breach of school bus rider rules as per each individual Board's code of conduct may result in the suspension of service.</p> <p>2.5 School bus operators are licensed under the Public Vehicles' Act and the Ontario Highway Traffic Act. The regulations made under these Acts impose certain duties and responsibilities on the operator or a driver employed by the operator regarding control and safety in the operation of school buses.</p> |

| | <p>2.6 School Boards may make exceptions to existing STSTB policy in the transportation of their students at the individual Boards expense.</p> <p>3.0 DAILY HOME TO SCHOOL TRANSPORTATION</p> <p>General Eligibility Provisions</p> <p>3.1 An Eligible Student will be a resident in the District for TBCDSB, LDSB or CSDCAB, who is registered in, and attending, a school operated by, or under, the jurisdiction of these Boards.</p> <p>3.1.1 Eligible students must apply for transportation when registering into a school and each year of secondary school when registering for courses for the following year.</p> <p>3.1.2 Students assigned transportation and reported as not riding for 20 or more consecutive school days will be removed from transportation upon notification to parent/guardian.</p> <p>3.2 Students may request transportation for locations other than their home address provided that:</p> <ul style="list-style-type: none"> a) The locations are within the school boundaries, and; b) Request is received from the parent and approved by the Consortium. <p>3.3 In accordance with the guidelines listed above, under specific circumstances as approved by STSTB Consortium, transportation may be provided from no more than two permanent pick-up points, and to one permanent drop-off point, within scheduled routes, to and from the student's designated home school.</p> <p>3.4 Distances will be calculated as the distance from the closest property line of the home to the closest property line of the</p> |

| | <p>3.6.1.3 The distance motorists need to see and slow down for a school bus is a key factor in setting stops. The stops must be sited where they are clearly visible to motorists. As a rule, a minimum 200 meter distance between bus stops will be followed.</p> <p>3.6.1.4 When not interfering with normal school operations, the loading zones of elementary schools will be utilized as transfer points and centralized bus stops for Secondary students of the same board.</p> <p>3.6.2 Secondary school students attending board of education programs outside their home school areas and who, during the school year, change to a program available in their home school, will no longer be eligible for transportation to the out of zone school.</p> <p>3.7 Students with Special Needs</p> <p>3.7.1 Students enrolled in Self Contained programs, or identified as exceptional students will be transported to designated schools in accordance with policy concerning distance between home</p> | Speed Limit | Minimum distance (for cars coming from each direction) | 50 km/h | 125 m | 60 km/h | 150 m | 70 km/h | 175 m | 80 km/h | 200 m |

Transportation will be provided at the discretion of the Director of Education or designate for injuries/medical conditions where the lack of access to school transportation presents a hardship for the parent/guardian at the expense of the individual Board.</p> <p>4.5 Transportation to Provincial Schools</p> <p>4.5.1 Transportation may be provided for students residing in our area to and from provincial schools operated by the Ministry of Education, any Ontario hospital, or a Mental Health Center established under the Child and Family Services Act, R.S.O. 1990. Use of video cameras on buses to monitor student behaviour will be with the approval of STSTB.</p> |

| | <p>6.0 DISCIPLINE ON SCHOOL BUSES</p> <p>6.1 In accordance with Ontario Regulation 298 under the Education Act, every pupil is responsible for his or her conduct to the Principal of the school that the pupil attends while traveling on a school bus that is under contract to a board. R.R.O., Reg.298 s. 23(4)</p> <p>6.2 The driver will report any student who does not abide by the established rules or follow the instructions of the driver, to the School Principal. The School Principal may withdraw transportation services.</p> <p>7.0 PUBLIC TRANSPORTATION</p> <p>7.1 Public transit system will be utilized where economical and time efficient. Public transit will be a consideration for the students at the secondary and/or senior elementary school levels for home to school transportation.</p> <p>8.0 TRANSPORTATION CONTRACTS</p> <p>8.1 The Boards shall contract annually with transportation companies for the transportation of students based on tendered prices.
